### **GOVERNMENT SCHEMES FOR**

#### **POST PANDEMIC ECONOMIC RECOVERY**

The first case of COVID-19 in India was reported on 30 January 2020. After that two kinds of shock overtook India: a health shock and an economic shock. Both of them are key sectors for a country's overall growth. It has lead to large disruptions in the economy.

The initial impact on the Agrarian Sector wasn't much as during the first lockdown the virus was more or less limited to cities. However, during the second wave, it was one of the worst hit sectors as COVID had penetrated into the villages. In the Manufacturing Sector, COVID put an immediate halt to many business activities due to strict social-distancina norms. Thousands of manufacturing units shut down forever and several thousand more were brought to their knees.

This sudden change in the manufacturing sector in turn affected the Service Sector. Sectors like Education, Gym, and Tourism witnessed a direct impact and the layoff of lakhs of workers.

All this needed to be dealt with firmly. Keeping this in mind, the government has launched various schemes in the past one and a half years related to this. The goal is to minimize the impact of COVID-19 and to maximize feeling of security to all the citizens and lift them economically.

Various schemes have been launched across many sectors but here we will be looking at a few policies which will impact the country's economy.

# Kalyan Ann Yojana

This scheme is a part of the Atmanirbhar Bharat, and it provides free food grains to migrant labour and poor. This is

find Work. People will be provided Emergency Credit Line to be with 5 kg free wheat / rice per person / month and also 1 kg free whole chana to each family per month. Wheat has been allotted to Punjab, Haryana, Rajasthan, Chandigarh, Delhi and there are no charges for Gujarat and the rest of the states/UTs have been provided with rice.

### **Production Linked** Incentive Scheme

In the Union Budget of 2021-22, a funding of Rs 1.97 lakh crores for the Production Linked Incentive Schemes for 13 key sectors. ### **PM Street Vendor's** AtmaNirbhar Nidhi
